The Purchaser and his/her guarantor (if any) shall provide sufficient documents to prove his/her repayment ability, including without limitation the provision of credit report, income proof, banking records and borrowing

records (including other loans (if any)) upon request by the designated company. The designated company will conduct credit check on the Purchaser and his/her guarantor (if any).

The Vendor is not, and will not, be involved in the arrangements of the Second Mortgage Loan. The Purchaser shall have no claims whatsoever against the Vendor as a result of or in connection with the approval and/or disapproval of the Second Mortgage Loan and/or any matters relating to the Second Mortgage Loan.

 - The Second Mortgage Loan is a transaction between the designated company and the Purchaser. The Vendor and Centralcon Properties Company Limited shall not be involved in any dispute between the purchaser and the designated company. The above information of the Second Mortgage Loan shall not be regarded as any representation, guarantee, warranty offer or terms of the agreement for sale and purchase made by the Vendor or any other parties. Under no circumstance shall the Vendor and Centralcon Properties Company Limited be liable to the Purchasers in respect of the Second Mortgage Loan.

 - Irrespective of whether the First Mortgage Loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the purchase price in full in accordance with the ASP.

 - The First Mortgage Loan is subject to other terms and conditions as shall be determined by the Designated Financing Company.

 - The First Mortgage Loan is a transaction between the Designated Financing Company and the Purchaser. The above information of the First Mortgage Loan shall not be regarded as any representation, guarantee, warranty, offer or terms of the agreement for sale and purchase made by the Vendor or any other parties. Under no circumstance shall the Vendor and Centralcon Properties Company Limited be liable to the purchaser in respect of the First Mortgage Loan.
