## 有關：「星凱·堤岸」住宅停車位銷售事宜

認購申請將分作（A 組）優越住客停車位認購權及（B 組）一般停車位認購兩組，以組別計，（A 組）將優先於（B 組）揀選車位，而每一組別之成功登記將以抽籤形式決定優先揀選停車位次序（詳見停車位之銷售安排）。本公司將於 2023 年 12 月 1 日（星期五）於沙田火炭坳背灣街 1 號「星凱·堤岸」會所 — 室內多功能運動場進行即場抽籤，揀選並出售停車位。

車位售價 10% （臨時訂金）	於買方簽署臨時買賣合約時繳付，買方必須在簽署臨時買賣合約後五個工作天之內簽署正式買賣合約。
車位售價 90% （售價餘款）	於成交時繳付（該成交日期為 2024 年 1 月 31 日（星期三）或之前，惟可受住宅物業成交日而變更（如適用））。
