- 6. The Attorney shall have no right of substitution and shall not delegate the powers herein conferred upon him to other person.

In this Power of Attorney, if the context permits or requires, words importing the singular include the plural and vice versa, words importing a gender include every gender and words importing persons only include corporations. Any reference to a Clause or Schedule, unless the context otherwise requires, is a reference to the Clause of or Schedule to this Power of Attorney.
- 9. This Power of Attorney shall be governed by the law of the Hong Kong Special Administrative Region.
